Instructions to the Voter:


- TO VOTE YOU MUST COMPLETELY BLACKEN THE OVAL TO THE RIGHT OF YOUR CHOICE.** An oval darkened to the right of any candidate indicates a vote for that candidate.
- To cast a write-in vote for a person whose name is not on the ballot,** you must darken the oval to the right of the line provided and print the name in the blank space provided for that purpose.
- Use a black pen or marker.
- If you make a mistake, **DO NOT ERASE.** Ask for a new ballot.

WARNING: If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on Election Day, unless you surrender your absentee or mail-in ballot and envelope to the judge of elections to be voided to vote by regular ballot.
